This letter contains information relating to changes in government guidance on Covid restrictions as well as general information that relates to all parents and students.

## POSITIVE LATERAL FLOW TEST

We have been made aware of a confirmed positive Lateral Flow home test (COVID-19) for a student in Year 10 attending Heathfield Community College. The children who have been in close contact with the individual who has tested positive for coronavirus (COVID-19) have been identified and parents have received a letter informing them that their child must stay at home for 10 days unless the resulting PCR test overrules this.

The school remains open and your child should continue to attend as normal if they remain well. ## CHANGES TO GOVERNMENT GUIDANCE

As you will be aware, on 11 May the Government updated the next steps in the roadmap out of Covid restrictions. We have considered our current restrictions in College and adjusted to reflect the updated guidance.

**Face Coverings:** From Monday 17 May face coverings will no longer be recommended for students in classrooms or communal areas in all schools, and for staff in classrooms.

We are aware that for some this will not be the preferred position and we remain clear that should students wish to, they retain the right to wear face coverings in classrooms or corridors. They have been fantastic at wearing them up until now and they will not be told to remove them if they choose to continue.

Students must continue to wear their masks on buses. This is clear in the guidance and we will be checking it is continued.

Face coverings should continue to be worn by staff and visitors in situations outside classrooms where social distancing is not possible (for example, when moving around in corridors and communal areas).

We do need to be clear that the full reintroduction of face coverings for students and staff may be advised in response to particular localised outbreaks, either within

Therefore, it would be advisable for all students to continue to be equipped with masks as they may be needed at short notice.

**Mitigation and Safety Controls:** The virus is still amongst us. It is vital that everyone within the College still acts in a way that keeps them and others as safe as possible. The following will remain in place as part of our safety controls:

- Social bubbles (separate social spaces and eateries)
- One-way systems with increased travel space outside
- Ventilation in classrooms
- Regular hand washing and additional sanitising in classrooms
- Regular and frequent cleaning of used spaces

Many staff have not had their vaccinations. Some staff and students will be understandably anxious, we expect mutual respect and consideration, along with complete adherence to the guidance. Please contact us if you are worried about your child's wellbeing.

As part of our continued vigilance the following measures also remain in place:

- Virtual assemblies and no large indoor gatherings
- Extra-curricular clubs as currently organised with consistent groupings
- All trips and events will operate as currently planned. It is too late notice and too restrictive on current guidance to re-introduce residential elements for this term. We will however take this into consideration in planning for the next academic year

**LFD testing:** This is a key part of safety controls and it is important that all members of our community who can, are remembering to test and report their results twice weekly to the NHS site, alerting the College to a positive result using <u>C19attendance@heathfieldcc.co.uk</u>.
