

# PRIVACY NOTICE – Visitors to the College

## INTRODUCTION

Heathfield Community College is a ‘data controller’ for the purposes of the Data Protection Act (2018) & UK GDPR. We collect a small amount of data about our visitors.

### We ensure that your personal information is:

- processed legally
- processed fairly
- correct
- stored safely
- kept for no longer than needed (see our retention schedule on the College website [http://www.heathfieldcc.co.uk/?page\\_id=1595711](http://www.heathfieldcc.co.uk/?page_id=1595711) )
- is deleted as soon as possible after the expiry of the retention period

### This document describes:

- why we collect data about you
- what data we collect
- what we do with the data we collect
- what your rights are.

## WHY DO WE COLLECT INFORMATION ABOUT YOU?

The legal basis for collecting your information is as follows:

- we have a legal obligation for the safeguarding of students when you are in College
- perform tasks that are in the substantial public interest for special category data
- comply with your consent for the processing of personal data and your explicit consent for the processing of special category data. If we need your consent, we will let you know.
- maintain “public health”, for example during a pandemic

We collect and store information about our visitors to:

- to meet our legal obligations to ensure the safety of our students
- ensure that appropriate access arrangements can be provided for visitors who require them

## WHAT INFORMATION DO WE COLLECT ABOUT YOU?

We collect the following information about our contractors and other suppliers:

- names (business & personal) & contact details
- your image & whilst on site your image may be recorded on our CCTV

## HOW DO WE STORE YOUR DATA AND FOR HOW LONG?

Your data is stored securely in line with our policies on data protection and online safety and IT security. We keep your data only for as long as we need to process it. The document that guides for how long we keep specific types of data is called our retention schedule. ## DO WE SHARE YOUR INFORMATION?

- We don’t share information about our contractors and other suppliers without consent unless the law and our policies allow us to do so. We will share information with legal authorities if asked to do so in line with a formal investigation. We will also share data to facilitate traded services

connected to your visit to us that are purchased through the LA (e.g. for Legal, Human Resources or Information Governance Support)

### TRANSFERRING DATA INTERNATIONALLY

The data that we store about you when signing into the college uses cloud storage with a UK datacentre that is certified to ISO 27001. We do not transfer your data outside of the UK.

### WHAT ARE YOUR RIGHTS?

There are circumstances when these rights don't apply, for example if a law says we need to keep specific pieces of information, or if not processing the data places a student in danger. Your rights are:

- **The right of access** (a "Subject Access Request"). This means you can ask for a copy of the data we hold about you. Contact details for this can be found below. We will comply within ONE calendar month
- **The right to rectification.** This means you can ask us to fix omissions and errors in your data
- **The right to erasure.** This means that you have the right to have information we hold deleted.
- **The right to restrict processing.** This means we can still hold the data, but can't use it.
- **The right to object.** This means you can object to processing of personal data that is likely to cause, or is causing, damage or distress. If we had to ask for your consent, you can withdraw consent at any time. Consent can be withdrawn by writing to the address below.
